Introduction

Sher-e-Kashmir University of Agricultural Sciences and Technology of Kashmir (SKUAST-K) is a multi-campus, multi-disciplinary and research-intensive university, with 6 academic campuses, 10 KVKs and 11 Research Stations. Over the years, since its establishment in 1982, SKUAST-K has emerged among top agricultural universities in the country in teaching, research, outreach and innovations. Presently it ranks as 4th best among 70 State Agricultural Universities, 1st in Innovations among all SAUs in the band of 11-50, and 1st in Innovation and Start-ups among 11 universities in J&K. SKUAST-K has earned 24 patents in the last 4 years including 8 patents in the first 2 months of 2024. During the same period, it has produced 26 Start-ups with Technology Readiness Levels of 5 to 8. These patents and start-ups, shared by the Students and Faculty, reflect the true mission of the University – of churning the bright, innovative Next Gen Global Leaders.

Inter-alia, SKUAST-K is at the core of the food, nutritional and economic security mission of the state. Our Shalimar Rice-4 (SR-4 variety) is a revolutionary one, with productivity levels 110 q/ha compared to national average of 25 q/ha. We have developed the first Kashmir *Basmat* Rice variety (a medium fine grain) with better aroma than any national variety, revived and commercialized our own landraces like *Mushkbudgi* and *Zag* rice variety, transformed our horti-sector from traditional to high density with 6 fold productivity from 10 to 60 t/ha. Similarly, SKUAST-K has made tremendous strides in all other fields viz veterinary and animal sciences, forestry, fisheries, agricultural engineering, food science, environmental sciences, sericulture and other allied sciences.

From here on, we aim to take a big leap to make J&K a model Bio-economy state of the country. Holistic Agricultural Developmental Project, approved at a cost of Rs 5013 Crore by Hon'ble Lt Governor J&K and dedicated by Hon'ble Prime Minister of India, was conceptualized, and scripted at SKUAST-K. To boost our agri-exports, we have framed JK EXIM Policy, as a guideline for the state and all stakeholders. For global competitiveness, SKUASTK is at forefront in embracing emerging technologies like Artificial Intelligence, IoTs and Automation, Precision and Smart Agriculture, Speed Breeding, Gene Editing through CRISPR Cas, genetically engineered vaccines, Regenerative Medicine using Stem Cell Technologies, Regenerative and Conservation Technologies. Integrated Pest & Disease Management and Integrated Nutrition Management, through development of bio-control agents, bio-fertilizers and bio-pesticides, is our renewed approach for protecting the soil, environment and human health.

To be there, we aim to build a globally competitive human capital and in pursuit, we have developed our own Model of Agri-Education that places focus on the outcome-based education - characterized by creative, entrepreneurial and industry-ready graduates. The Vision, Mission and expected outcomes are presented in the following pictorial illustration to provide first-hand information to the applicants seeking admission in the University during the session 2024-25.

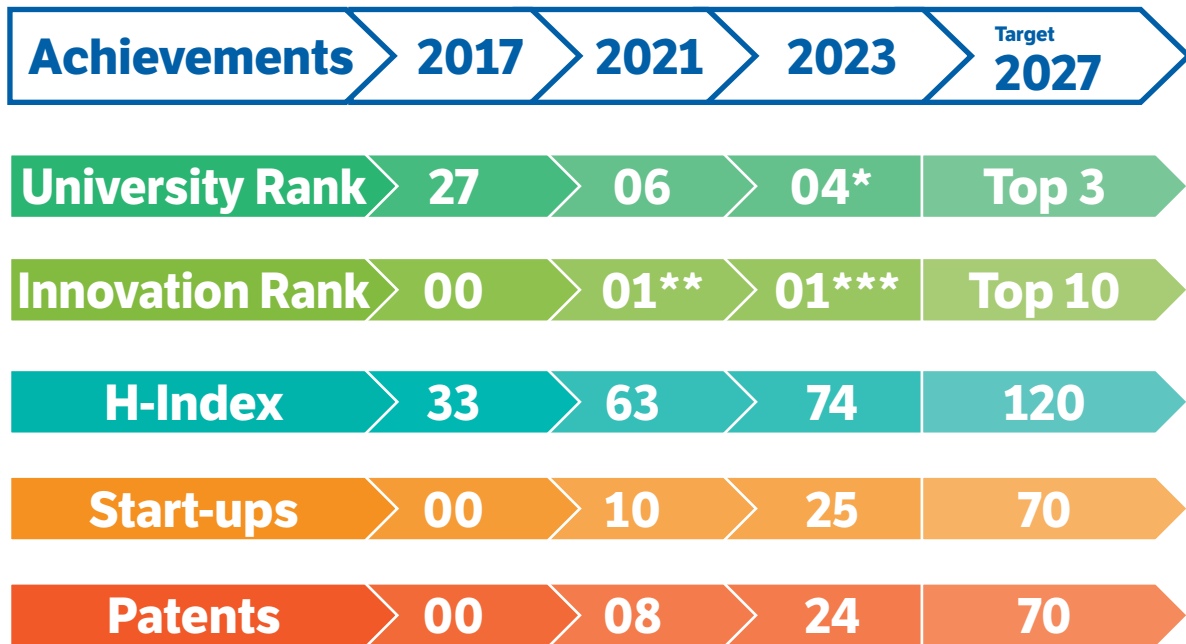

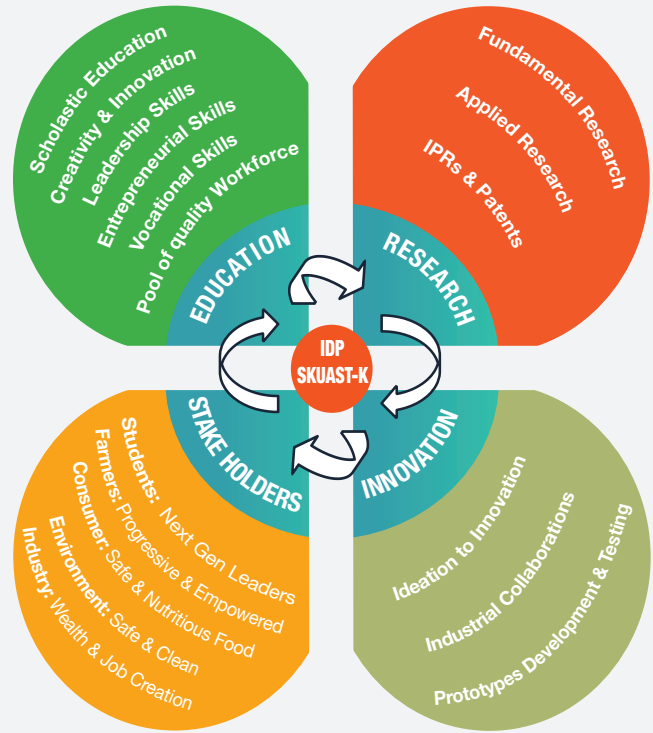

Faculty of Agriculture (Wadura, Sopore)



The Faculty of Agriculture was established in the year 1960 as the erstwhile Govt. Agriculture College situated at Wadura which is 10 km from the apple town of Sopore. With the establishment of SKUAST in 1982, the college became a constituent unit of university as Faculty of Agriculture offering UG courses in Agriculture, Forestry, Horticulture and Sericulture. With the reorganization of units, Forestry and Horticulture were upgraded as the Faculties of Forestry and Horticulture and relocated at Benihama and Shalimar respectively. The faculty is well connected with the main cities of India and abroad by air and surface transport. Srinagar international airport is 56 Km away from the faculty. The faculty has produced around 6000 graduates and postgraduates who are serving at state, national and international levels in different capacities in developmental departments, academic and research institutions. The faculty is spread over an area of 92 hectares with huge physical infrastructure comprising of an administrative block, three academic blocks having nine state of art smart class rooms, well equipped UG and PG labs, a rich library and information centre with more than 25000 books and CD ROM collection. The internet and computer/IT set-up is managed through a centralized Knowledge Management Centre. The faculty has nine major divisions. Currently there are more than 750 UG and PG students on the Campus, including students from foreign countries and other states of India. There are adequate logistic and hospitality facilities on campus including Health Centre with 24 x 7 medical service support, Bank with ATM, student Facilitation Centre, Gymnasium, Auditorium as well as facilities for indoor and outdoor games. Adequate residential facilities with eight hostels (3 boys and 5 girls), residential quarters for faculty and a guest house are available. The faculty also has a state of art bio-fertiliser research laboratory with 1000 litre capacity fermenter, a multi-crop seed processing plant, dairy unit as well as instructional farms and orchards including a model IFS system. Graduates from the Faculty occupy technical positions in Agriculture, Horticulture, Sericulture, Rural Banking institutions rural development. Good number of students qualify civil services examinations and adorn administrative positions. Besides students find placement in industry or start their own ventures and consultancies in the field agricultural production, post production and marketing.

Faculty of Horticulture (Shalimar)



Horticulture industry in J&K has emerged a strong component of agri-economy and established its credibility in improving farmer's income, generating employment and enhancing exports, and providing household livelihood security. The faculty of horticulture though created in 2007 started functioning from April, 2014 as an independent entity following the University Council decision and approval from the Government of Jammu and Kashmir. It is located at Shalimar, Srinagar about 14 km away from city center and 27 km and 20 km from the Srinagar international airport and railway station, respectively. The Faculty of Horticulture offers five Bachelor's programs of four years duration, Masters in 12 and PhD in 08 disciplines besides certificate and diploma courses in various vocations. Faculty is equipped with state of art infrastructure which includes 54 world class modular labs including a NABL accredited Residue Analysis & quality Control lab, two BSL-2 labs, 8 independent centers of excellence, 8 Instructional Farms, 40 protected structures (high tech & semi controlled) and 18 IT enabled smart classrooms along with a cluster of separate hostels for boys & girls and Guest houses. FoH is taking up short and long term research projects on cutting edge themes and has developed strong collaborations in research with number of National and International institutions including, viz., ICAR, UGC, ICAR, DST, DBT, ICSSR, NABARD, APEDA, BARC, IITs, Ministry of Agriculture, Government of India and German Research Foundation, Germany, IFPRI, FAO, US and Australian institutions and state institutions like Central University of Kashmir, University of Kashmir, Islamic University of Science & Technology, Agriculture Production Department, UT of J&K, etc. The faculty endeavors to prepare the students to keep abreast of latest development and innovations in Horticulture education, research, governance and policies. The programmes offered by the faculty are perfect blend of academia, research and industry interface. Graduates get place in development departments as well as industry viz protected cultivation, Agri-Horti inputs, high density orchards, post-harvest management and value addition.

Faculty of Faculty of Veterinary Sciences and Animal Husbandry (Alusteng, Shuhama)



Faculty of Veterinary Sciences and Animal Husbandry (FVSc & AH) was established in Year 1984 as a constituent unit of SKUAST-Kashmir. initially at Nowshera, Srinagar but was later shifted to its present location of Shuhama, Alusteng, The campus is well connected with wide network of roads and is located at a distance of about 18 km from city center Lal Chowk and about 27 km from International Airport at Srinagar and Railway Station at Nowgam Srinagar. The Faculty of Veterinary Sciences & Animal Husbandry, Shuhama offers Bachelor of Veterinary Sciences & Animal Husbandry (BVSc & AH) degree programme & Masters in Veterinary Sciences (MVSc) in 18 disciplines while Doctorate degree programme (Ph.D.) in 17 disciplines in the field of Veterinary & Animal Sciences. Faculty spread over 120 hectares of land has 83 state of art divisional laboratories, 10 IT enabled smart classrooms, one library complex, two central computer labs, one complex dedicated as student facility center, six well established hostels for the students, one faculty outreach center for extension activities, five dedicated playing fields, one referral Veterinary clinical complex and animal birth control facility along with other required facilities at its campus. The division of Veterinary Microbiology & immunology has been granted Niche Area Excellence center in Anaerobic Bacteriology by ICAR, New Delhi. The faculty has also state of art animal fiber testing lab, center of excellence in antimicrobial resistance, two BSL-2 labs, two big animal farms in the form of Mountain Livestock Research Institute (MLRI) at Manasbal, Ganderbal & Mountain Research Centre for Sheep & Goat (MRCSG) at its Shuhama Campus.

The Faculty gained nation reputation as Star Status College under Start College programme of Department of Biotechnology Govt of India. It is birth place of first clone of Pashmina Goat **“Noori”**. Other research achievements include Vaccine development against animal disease, introgression of Fec-B gene in sheep, fabrication and table top paddle operated Charka and characterization of livestock germplasm and development of minimal invasive surgical procedures and anesthetic protocols.

Veterinary graduates besides getting placed in department of Animal and Sheep Husbandry, occupy administrative position in large numbers by qualifying civil service examinations. Certificate and diploma courses have been initiated to further diversify the portfolio towards entrepreneurship.

Faculty of Forestry (Benhama)



The Faculty of Forestry (Benhama) is located in the Ganderbal district of J&K along the foothills of Lar mountains. Spread over 50 hectares of land, the faculty is about 40 Km from Capital City Srinagar on Srinagar -Leh road. The faculty is connected by air from all the capital cities of India and some international destinations by Srinagar International Airport which is 47 km away from the faculty. Nearest railway station is located at Nowgam Srinagar at a distance of 48 km. Faculty of Forestry (SKUAST Kashmir) has its roots in erstwhile Division of Forestry, Faculty of Agriculture established in 1987 to impart quality and holistic technical forestry education in the state of J&K. In the year 2007, the division of forestry was accorded status of full-fledged Faculty. At present, Faculty of Forestry has students from various states of India and abroad as well on its rolls, pursuing forestry education in different disciplines, like Silviculture and Agroforestry, Forest Biology and Tree Improvement, Forest Products and Utilization, Forest Resource Management, Wildlife Sciences, and Social and Basic Sciences. A comprehensive resident instruction programme for BSc, MSc and PhD Forestry at this faculty with the objective to impart quality professional education for providing competent, practical oriented and skillful human resource base of professional forestry and post graduates is being carried out since 1986-87. The learning process and its standard has been continuously improved and as a reason the faculty has been accredited with “A” grade by ICFRE (Indian council of Forestry Research and Education) and ICAR(Indian Council of Agricultural Research). Faculty has a 50-ha experimental farm comprising Medicinal and Aromatic Garden, Agro- Forestry Farm, Biodiversity, Lavender and Rosemary Park. It has a two academic blocks, three hostels, administrative block, examination cum auditorium hall, library information technology Geo-informatics, Forestry products, Silvi culture lab and many other labs.

Faculty of Forestry has got the distinction of having more than 80% of its Alumni working in various sectors including the prestigious Agriculture Research Services (ARS), Indian Forests Services (IFS) Jammu & Kashmir Administrative Services (JKAS), Banking Services besides State Forest department. The practical knowledge imparted to the students can give them jobs in forest-based industries viz. paper & pulp mills, plantations, wood-based industries, herbal industries besides they can have their own start-ups.

Faculty of Fisheries (Rangil Ganderbal)



Faculty of Fisheries is one of the constituent units of SKUAST-K established in August, 2005 and is the country's first Faculty (College) with the domain of Coldwater/Hill Fisheries. Besides its primary mandate of Teaching, Research & Extension, the college has become a common facility for other hill states of the country like Arunachal Pradesh, Sikkim, Uttaranchal and Himachal Pradesh as two seats each in UG and PG are reserved for these states for Human Resource Development specific to hill/cold-water fisheries. Faculty of Fisheries at present is offering Bachelor in Fisheries Sciences (BFSc), Master in Fisheries Sciences (MFSc) in ten disciplines and Ph.D in six disciplines.

Faculty of Fisheries located at Rangil, Ganderbal is 19 km from Srinagar city center, 33 km from Srinagar airport, 25 km from the Nowgam railway station and 16 km from SKUAST-K headquarters (Shalimar).

Faculty of Fisheries is having one Girls Hostel and one Boys Hostel. Faculty has two Fisheries Instructional Farms, one located at Shuhama for Carps and Shizothoracids comprising fourteen (14) fish ponds, one flow through hatchery and one circular hatchery and the other at Rangil for Trout culture with sixteen raceways, 5 ponds, one hi-tech poly house, one ornamental unit, one feed Mill, and one hatching unit. Beside the faculty has a distinction of establishing a fish hospital.

The graduates find placement in state department of Fisheries and other R&D Institutions. The skill and entrepreneurial training enable graduate to have their own startups & choose entrepreneurship.

College of Temperate Sericulture (Mirgund)



College of Temperate Sericulture SKUAST-Kashmir was established during the year 1980 as Sericulture Research Centre of Sericulture Development Department (J&K Govt.). It was transferred to SKUAST in 1982 and re-christened as the Division of Sericulture and later upgraded as College of Temperate Sericulture with five independent divisions in 2006. The College is one of the pioneer establishments which caters to the needs of temperate sericulture research of country and that of Union Territory of Jammu and Kashmir and is located on the right side of Srinagar-Baramulla-Uri national highway at Chainabal, Mirgund, 18 Km from City Centre, Srinagar, Jammu and Kashmir. The College is equidistant (28 Km) from nearest railway station (Nowgam) and Srinagar International airport and is well connected by taxis and public transport vehicles.

The college occupies an area of 20 hectares with 02 hectares under operational buildings including Administrative-Block, Academic block, Cold storage and Divisional laboratories. The college has a boy's and girls' hostel. The college is maintaining a rich and diverse collection of genetic resources of silkworms and mulberry accessions. The college offers various degrees including BSc, MSc and PhD in sericulture, besides Certificate and Diploma courses with specialization in different modules.

Our graduates besides finding placement in Sericulture development Department find place in banking and other academic & research institutions as well. Further skill-oriented courses offered by the college open up avenue of start-ups and lead to Sericulture based enterprises.

College of Agricultural Engineering & Technology (Shalimar)



The College of Agricultural Engineering and Technology was established in the year 1987 as one of the constituent divisions of the SKUAST-K with the objective of catering to the teaching, research and extension needs of the State of Jammu and Kashmir in the discipline of Agricultural Engineering. It is further upgraded to College of Agricultural Engineering & Technology with 06 divisions in 2020. The college is situated at foot hills of Zabarvan at main campus of the Sher-e-Kashmir University of Agricultural Sciences and Technology of Kashmir, Shalimar, Srinagar and is well connected with the main cities of India and abroad by air and surface transport. It is situated about 27 km from Srinagar Airport, 14 km from Lal Chowk, Srinagar and 24 Km from Srinagar railway station. The famous Shalimar Mughal Garden is at walking distance from the College. Currently, the College is imparting resident instructions in B.Tech. (Agricultural Engineering), M. Tech. (Soil and Water Conservation Engineering; Farm Machinery and Power Engineering; Processing and Food Engineering, AI in agriculture, Renewable energy engineering and Irrigation and drainage engineering) and PhD in Soil and Water Conservation Engineering, Renewable energy engineering and Irrigation and drainage engineering. The College has well established infrastructure facilities viz. research laboratories, smart class rooms, video conference hall, auditorium, computer lab, CAD lab, engineering workshop, farm machinery testing laboratories, gymnasium, playground, dispensary, post office, bank, canteen, library and research farm. The college campus and hostels are provided with high-speed internet access. The College also has a state of art Farm Machinery Testing center, a protected cultivation fabrication unit and a farm machinery manufacturing unit. The college has developed several technologies for farmers which have been validated and tested at the university level and also at farmers' fields. College has conducted various industry academia interface to improve the collaboration with industries and to improve the student placement opportunities.

The candidate seeking provisional selection/admission must be a domicile of UT of J&K/UT of Ladakh, having passed 10+2/Higher Secondary Part-II or equivalent examination from a recognized Statutory Board/University with English, Physics, Chemistry and Biology/Mathematics having aggregate marks not less than 50% for OM and 40% for reserved category candidates with age group of 17-28 years as on 31-12-2024 within the age group as on 31-12-2024 of minimum 17 years and maximum 28 years (not born after 31-12-2007 and before 31-12-1995), however, minimum 21 years and maximum 37 years in case of Nominees of GoJK:

5. Programmes and Eligibility Criteria/Requirements for Masters Degree Programme

The candidates seeking admission to Master Degree Programmes, should have graduated/ obtained their Bachelor's degree from the Institutions/Universities recognized by the ICAR/VCI/UGC and must possess Bachelor's degree of 10+2+4 or above duration in the concerned/related field (Except MBA and Masters programme in Environmental Sciences/Plant Physiology/Microbiology/Biochemistry where 10+2+3 candidates are also eligible but will have to undergo deficiency courses at Masters level) as per the discipline wise eligibility shown against each below with OGPA not less than 3.25 on 4.00 scale or 6.50 on 10.00 scale or 65% aggregate marks in annual traditional system..

6. Minimum Residential Requirements

All Masters Degree programmes are of two (02) years duration, comprising 04 (Four) semesters. A candidate is required to complete requisite course work and thesis research work to earn the degree. Deficiency courses if required would be over and above the normal duration.

6.1 Sandwich Mode

As a sequel to NEP-2020 Post Graduate Programme at SKUAST-K from the Session 2023-2024 will be offered in Sandwich Mode (SWM) . Sandwich Mode means that a PG student is required to spend at least one semester for his/her research/course work at an Agricultural Institution within the Country other than his/her Parent University (SKUAST-K). The University shall facilitate/arrange his/her placement in other Agricultural Institutions under Sandwich Mode (SWM). However, all the expenses on account of travel, boarding and lodging and other contingencies at the host institution will be met by the student himself/herself to complete Sandwich component in partial fulfilment of the requirements for award of the PG Degree Programme by SKUAST-K.

Note: The necessary details for determining the modus operandi shall be worked out separately and finalised by the Competent Authority of the University for notification accordingly.

(For all candidates)

Note: (i) The candidates must carefully go through the e-Information Brochure-2024 in their own interest and to update themselves visit regularly the University official website www.skuastkashmir.ac.in.

(ii) The candidate(s) who have appeared or are likely to appear in the final examination of the qualifying degree may, subject to their meeting other eligibility criteria/requirements of admission, also apply provided the required degree is awarded and valid documentary proof thereof submitted by or before last date of Counselling.

1. The candidate seeking admission must be the bonafide domicile of UT of J&K or UT of Ladakh, within the age group of minimum 17 years and maximum 28 years as on 31-12-2024 (not born after 31-12-2006 and before 31-12-1995. However, not less than 21 years and not more than 37 years in case of in-service nominees of GoJK.
2. Photographs must be snapped on or after 01-01-2024 with placard indicating thereon name of the candidate and the date on which photograph taken.
3. The candidates are in no case required to send through post any of the document/credential including proof of having deposited the fee; in case so done by any candidates, the same shall be ignored at the risk & responsibility of such candidate.
4. The candidates are advised to compulsorily retain with them for future reference the print out of the confirmation page of On-line Application Form, proof of fee paid etc.
5. University Entrance Test (UET-2024) is mandatory for seeking admission under all categories including 'Self Finance'. However, following categories of candidates need not to appear in the UET (2024);
 - (i) seeking provisional selection/admission under NRI-sponsored and Other States/UTs category.
 - (ii) seeking provisional selection/admission in B.Tech (Agri. Engg) Degree and have appeared in Joint Entrance Examinations, Mains (JEE,)Mains.
6. The University shall endeavor to complete the admission process in all categories including upgradation/change of stream within the time frame fixed under "important events/ dates". Thereafter the admission process may invariably close even if some seats under any category are left unfilled; such seats shall be deemed as lapsed.
7. The selection of candidates shall be provisional till determination of the final eligibility of the candidate(s) at the concerned Faculty/College
8. In addition to the intake capacity under Open Merit, including reserved categories, there are some seats available under Self Finance category as indicated in the Information Brochure-2024 under "Availability of seats in different Faculties/Colleges". Only those candidates who appear in the University Entrance Test 2024 are eligible for admission under Self Finance category seats and the selection will be made on the basis of overall merit secured in the Test-2024. Moreover, 15% seats of over and above intake capacity earmarked under open including reserved categories for Undergraduate Degree Programmes excluding B.V.Sc & A.H shall be filled by ICAR. Similarly 15% seats of over and above intake capacity earmarked for B.V.Sc & A.H Degree Programme shall also be filled by VCI on the basis of merit obtained in NEET 2024. Besides the seats bearing B.V.Sc & A.H. Degree Programmes, earmarked for nominees of Govt. of J&K in-service candidates spelled out in the seat matrix, who too are required to appear in the UET-2024 and subsequent to that having nomination letter from employer concerned.
9. Merit obtained by the candidate in UET-2024 shall determine the choice of programme.
10. There will be no negative marking
11. The Answer Key will be uploaded on the SKUAST-K website www.skuastkashmir.ac.in within 48 hours after completion of Test which will remain available on it for 03 days. The candidates who have any complaint against answer(s) of any question(s) in the Question Paper are free to make written representation supported by documentary proof based on standard text which should reach Controller of Examinations, SKUAST-K, Shalimar, Srinagar-190025 within a period of 03 days after the Key is

uploaded on the university website and thereafter no representation will be entertained/ accepted.

12. The material downloaded from the Internet will not be accepted as proof.
13. The Answer Key will be got re-examined by the University on the basis of the representations so received and the revised key, if any, will be final and no complaint thereafter will be entertained regarding the revised key. The Revised Key, if any, will be uploaded on the website of the University and applied to Answer Sheets of all the candidates no matter whether they have made such representations or not.
14. OMR Answer Sheets of candidates are machine graded and scanned / scrutinized and double checked with extreme care. As such, there shall be no re-evaluation/ rechecking of OMR Answer Sheets.
15. The records of the UET-2024 shall be preserved for a period of six months only from the last date of counseling (closing of admission)..
16. Ragging in any form inside or outside the University Campus is a cognizable offence under law.
17. Limited hostel facilities are available for housing students. Subject to availability, the preference will be given to those residing outside UT/province/district.
18. Since, University is neither an appellate authority nor an investigating agency, the complaints against the credibility of certificates including those of reserved categories will not be entertained at University level .

The candidates having “Outstanding Proficiency in Sports” must submit their certificates to the Secretary, J&K Sports Council which will be then officially forwarded to the University by the Sports Council. Entrance Test will consist of a single sitting paper. The question paper for Stream 01 shall comprise multiple-choice questions, with 45 questions each from Physics, (serially numbering from 1 to 45), Chemistry (serially numbering from 46 to 90), Biology (numbering from 91 to 135). For Stream 02 it shall comprise of 135 questions with 45 questions each from Physics, (serially numbering from 1 to 45), Chemistry (serially numbering from 46 to 90) and Mathematics (numbering from 91 to 135). For Stream 03 it shall comprise of 180 questions with 45 questions each from Physics, (serially numbering from 1 to 45), Chemistry (serially numbering from 46 to 90), Biology (numbering from 91 to 135) and Mathematics (Serially numbering from 137-180) For Stream 04 question paper shall comprise of 100 questions with 20 questions each from General English, General Sciences, General Knowledge, General Mathematics and Computer Applications subjects. Time duration of the Test for Stream 01 & 02 shall be 02 Hours & 15 Minutes (135 minutes) and for Stream 03 it shall be 03 hours (180 minutes) and for stream 04 it shall be 1 hour and 40 minutes (100 minutes) keeping one minute per question in each case.

NOTE: Allotment of seats will be made strictly in order of merit obtained by the candidate in the UET-2024 viz-a-viz eligibility with regard to the discipline in accordance with prescribed discipline wise eligibility requirement & eligibility criteria together with availability of seats in the respective disciplines indicated in the Admission Notice- 2024 read with Information Brochure-2024.

5. Syllabus

5.1. Undergraduate Degree Programme

The question papers will be based on the latest syllabus adopted by J&K Board of School Education (JKBOSE) for 11th & 12th classes.

5.2 MASTERS DEGREE PROGRAMME

Syllabus in respect of various disciplines/Streams, as the case may be, of Masters degree Programmes courses will be based on ICAR/VCI syllabus. The syllabus will be separately and subsequently made available by Controller of Examination, SKUAST-K on the University website: www.skuastkashmir.ac.in.

6. ADMIT CARD

1. Entry in the Test Centre/venue shall be subject to production of valid Admit Card only.
2. The Admit Cards will be available online. The candidates are advised to download their auto generated Admit Cards from the University website: www.skuastkashmir.ac.in about a weeks' time before the date of UET-2024.
3. Candidate shall have to preserve the Admit Card in their own interest till the completion of admission process by the University.
4. If a candidate is not in a position to download the Admit Card for any reason, he/she may contact the Controller of Examinations at least one day before the date of UET-2024.
5. No admit card will be issued on the day of entrance test.

7. CENTERS OF EXAMINATION

7.1 For Undergraduate Degree Programme

1. The Entrance Test shall be held at the centers as may be notified by the University in the cities of Srinagar/Jammu only in due course of time.
2. The centers shall be allotted by the University and the information regarding this shall be provided to the candidates on the Auto generated Admit Cards.
3. The Test Centre once allotted shall not be changed under any circumstances.

The Entrance Test shall be held at main Campus Shalimar, Srinagar

8.2 The University Entrance Test-2024 for provisional selection/admission to Masters Degree Programmes shall be held on the date's & time as per the examination scheme as may be separately & subsequently notified by the Controller of Examinations;

9. Scheme of Examination

1. The medium of test will be English only.
2. The candidates have to report 01 hour before the scheduled time of commencement of Test and occupy their respective seats to facilitate verification of candidature etc.
3. Candidates arriving late by more than half an hour after starting of examination will not be permitted to appear in the Test.
4. The candidates can be allowed to leave the examination hall after half of the time is over.
5. The test will be of objective type. The candidates will be provided with a question paper booklet and an OMR answer sheet.
6. Question paper booklet will have Multiple Choice Objective Type Questions. Each question will be followed by four alternatives marked as A), B), C) and D), out of which only one will have to be marked in OMR answer sheet.

7. OMR Answer Sheet:

- i. As the OMR sheet is scannable on optical scanner, the candidate must ensure that the OMR answer sheet is not folded and no stray marks are made on it.
- ii. The candidates will fill-in the following particulars on the OMR Answer Sheet in the appropriate box(s):
 - a. Roll No.
 - b. Question Paper Booklet No.

- c. Series of the Booklet
- d. Signature of the candidate

8. Marking Responses in OMR Answer Sheet:

1. The candidate shall indicate his/her response to the questions by darkening the appropriate circles/ovals completely.
2. If more than one circle against a question is darkened or if the response is marked in any other manner, the answer shall be treated as wrong and shall be rejected.
3. A slight or faintly darkened circle may also lead to rejection of answer.
4. If the candidate does not want to attempt any question, he/she should leave it blank.
5. For each correct response the candidate will get one mark.
6. There will be no negative marking.
7. If a candidate puts any identification mark on the OMR sheet, the same shall be cancelled.

8. Important instructions for marking:

1. Darken the appropriate circle with blue/black ballpoint pen only.
 2. Completely darken only one circle for each entry/question.
 3. Make the mark only in the space provided in the OMR Answer Sheet. Erasing, cutting and overwriting are not allowed.
9. Candidates should not make any type of marking on the Question Booklet/OMR Answer Sheet. All rough work should be done in the test booklet only.

10. Procedure to be followed in the Examination Hall:

1. The candidates shall bring their own ball point pens of good quality. These will neither be provided nor allowed to be borrowed in the examination hall.
2. Carrying of cell phone, pager, calculator or any other electronic gadget to the Test Centre is strictly prohibited. Neither will SKUAST-K make any arrangement for the safety of these items nor will it be responsible for loss/theft/damage of any such item.
3. Sealed question paper booklet along with OMR answer sheet will be provided to the candidates ten minutes before the commencement of the Entrance Test-2024.
4. Immediately on receipt of the question paper booklet and OMR answer sheet the candidate will fill in the required particulars on the cover page of the question paper booklet/answer sheet with ballpoint pen only (blue/black) and go through the instructions. He/She will open the seal of the question paper booklet only when asked to do so by the Invigilator.
5. It shall be the sole responsibility of the candidate to check the question booklet before attempting to answer any question. Where a question booklet has any missing page, blank page, missed question or damaged or defaced page, it shall be the responsibility of the concerned candidate to bring it into the notice of the concerned Invigilator and get it replaced by a new booklet of the same series.
6. The test will start exactly at the time mentioned in the Admit Card and an announcement to this effect will be made by the Invigilator.
7. During examination time, the Invigilator will check the admit card of the candidate and satisfy himself/herself about the identity of each candidate. The Invigilator will also put his/her signature at appropriate place provided on the answer sheet.
8. After completing the Test and before handing over the question paper booklet and answer sheet, the candidate should check again that all the particulars required in the question

paper booklet and answer sheet have been correctly written. Ensure that the Roll No. and other particulars are correctly written in the OMR answer sheet.

9. A signal will be given at the beginning of the Test and at half time. The final signal will be given at the closing time when the candidate will stop marking the responses.

12. Selection Procedure

10. Entrance Test based overall Merit list of all the candidates, among whom short listed candidates in order of merit, shall be called for counseling as per the schedule at the Main Campus Shalimar to be separately notified by the Registrar through University website www.skuastkashmir.ac.in and local English/ Urdu Daily newspapers of UT of J&K. The candidates shall be allotted available seats in order of category wise merit obtained by the candidate.
11. The candidates short-listed for the counseling for admission to various Masters & Undergraduate Degree Programmes will have to submit duly completed 'Counseling Form' (to be provided at the time of counseling) along with one set of attested copies of all the relevant documents.
12. The eligibility for the candidates will be verified by the counseling/selection committee and recommend for admission to different programmes as per merit.
13. If a candidate fails to register himself/ herself and deposit the fee at the time of counseling/ admission, his/her candidature will be cancelled and seat allotted to the next candidate on merit in respective category
14. Closure of admissions: After closing date of admissions (last counseling) held, the university shall not entertain/consider any request for change of stream from one programme to other, up-gradation from Self Finance to Open Merit/Reserved Category.

14. Counseling

Note: In case Counselling is held in offline mode, the following terms & conditions shall apply. However, in case the counselling is held in online mode the terms & conditions therefor shall be notified separately & subsequently for information of and necessary action by the eligible candidates, as the case may be.

1. The candidates have to keep ready the following at the time of counseling:
 - a. Residence/Domicile Certificate of UT of J&K and UT of Ladakh
 - b. Marks Certificate of the qualifying examination issued by the concerned Board/University
 - c. Matriculation/Secondary School Certificate indicating Date of Birth
 - d. Category certificate under which claiming benefit of reservation
 - e. 04 numbers of passport size color photographs
 - f. Requisite fee prescribed for the degree programme
2. All original certificates/testimonials and other documents relating to admission issued by the competent authority including admit card etc. are to be presented on the date of counseling. The candidates who do not produce original certificates/testimonials at the time of counseling shall not be entertained and shall lose their right to admission.
3. In addition to the original certificates/testimonials as at (2) above, the candidates offered seat shall have to pay non refundable counseling fee of Rs. 1000 /-. In addition to normal prescribed fee for the programme. The facility of depositing the fee shall be available in the Counseling Hall through J&K Bank Ltd. Branch of SKUAST-K.
4. No separate intimation will be sent to individual candidates for appearing in counseling sessions. The candidates are advised, in their own interest, not to miss counseling, **lest** they may lose the seat of their choice.
5. The candidates have to appear personally for counseling. If, however, for some unavoidable reasons, it is not possible for a candidate to appear personally, he / she may send his / her duly authorized representative with admit card, counseling fee, original documents, undertaking and authority letter to the effect that allotment made on the

basis of choices indicated by such representative shall be binding on him/ her.

6. Where a candidate or his authorized representative fails to appear for counseling at the time of his/her turn of counseling, his/her seat shall be allotted to the next candidate in order of merit, and if candidate, who has missed the counseling appears afterwards in the counseling on the same day, he/she shall be allotted the seat available at that point of time.
7. Where a candidate or his/her representative fails to appear for counseling on the specified date but appears on the next date or any date during subsequent notified counseling schedule, he/she will be allowed to participate in such counseling and he/she will be considered for the allotment of course/stream/institution available at that point of time on merit. Such a candidate cannot stake claim on any other seat already allotted despite superior merit.
8. Where a candidate has been kept in the waiting list and his/her seat is not confirmed, he/she is entitled to refund of counseling fee of Rs 1000/.
9. Candidates shall have to join the course after allotment of streams/ institutions within the specified time period. Where a candidate does not join the course/ institution allotted within the period so specified, his/her seat shall automatically stand cancelled and he/she shall have no claim on the seat. The same shall be filled up as a vacant seat
10. The short fall, if any, after first round of counseling shall be filled up in another round of Counseling as per the merit and availability of seat(s).
11. Where a candidate is allotted a seat in the upgradation counseling, his/ her vacated seat will be allotted to another candidate in order of merit.
12. The residual seats, which will become available after second round of counseling, will be allotted in the third round and so on strictly in order of merit.
13. Where the number of candidates, who turn up for counseling, is more than the seats available, a wait list will be prepared, which will operate after receiving a list of vacant seats from the respective Faculties/Colleges.

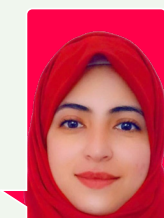

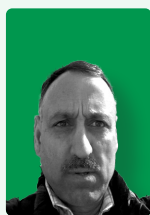

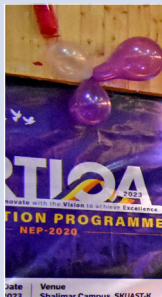
